2. Natural person: a certified true copy of valid identification card/passport (in case of non-resident).
3. Juristic person: copy of the company's affidavit issued by the Department of Business Development not later than 90 days and certified true copy of valid identification card or passport (in case of non-residents) of authorized signatories.
4. In case shareholder(s) has changed their title, name, or surname, the certified true copy of evidence of those changes must be enclosed.
5. In case shareholders have unified to propose the agenda, each shareholder must individually fill in this form and affix their signature as evidence, then consolidate and submit to the Company in one batch.
6. In case shareholder(s) would like to propose more than one agenda item, the shareholder(s) must complete one set of this form per one agenda item.

i-Tail Corporation Public Company Limited (the “Company”) values the importance of the personal data of each of its shareholders who will propose agenda items for the Annual General Meeting of Shareholders and/or nominate candidates as directors and would like to inform you that the details of the protection and the treatment of your personal data under the personal data protection law. The Company, therefore, informs you of the following information.

### 1. Your Personal Data Collected by the Company

The Company requires the collection of your personal data for the purpose of proposing the agenda items of the Annual General Meetings of Shareholders and nominating candidates for election as directors of the Company: general personal data such as name, surname, age, address, telephone number, mobile phone number, email, identity card number, passport number, evidence of shareholding for shareholders; including work experience and personal records of nominating candidate for election as directors of the Company.

### 2. Objectives and Legal Basis for Collection, Use, Processing, or Disclosure of Data and Personal Data

The Company collects, uses, processes, or discloses your personal data in accordance with the legal basis below.

#### a) Legal basis

The Company collects and uses your personal data for the purpose of proposing agenda items of the Annual General Meetings of Shareholders and nominating candidates for election as directors of the Company, including verifying your identity and carrying out other activities so as to comply with the law or the orders of governmental authorities in accordance with the Public Limited Companies Act B.E. 2535 (A.D. 1992), the Civil and the Civil and Commercial Code, or other laws.

#### b) Legitimate Interest

The Company collects and uses your personal data according to item no.1 for the purpose of considering the qualifications of nominated candidates for election as directors of the Company, for retention as evidence of proposed agenda items of the Annual General Meeting of Shareholders, and related to the legitimate interests of the Company and other persons, to the extent that it is within the scope of the Company’s objectives which you can reasonably expect.

### 3. Source of Personal Data

The Company collects your personal data directly from you, and/or Thailand Securities Depository Co., Ltd., and/or the nominated shareholders.

### 4. Personal Data Disclosure

The Company expects to keep your personal data for a period of 10 years from the date of the AGM. After these periods elapse, the Company will either destroy or anonymize your data.

### 5. Disclosure of Personal Data Transfer

The Company may disclose or transfer your personal data to related persons or entities, such as service providers, legal advisors, and government agencies or officials authorized by law. The Company will only disclose or transfer your personal data to service providers to the extent necessary for providing the service and will take steps to ensure that they do not use your information for other purposes.

### 6. Rights of Data Owners:

As the data owner, you have the right to receive a copy of your personal data, correct any mistakes in it, have it erased, and withhold consent for it to be used. The Company will review your request and respond to you as soon as reasonably possible.
